

Waiver for Hālau Maluhia, Ke’ei, Kona Hema, Hawai’i

PLEASE READ BEFORE SIGNING

By signing below, I recognize and acknowledge, for myself and/or for the child (if I am signing on behalf of any child as indicated below), that there may be hazards and risks in visiting at/nearby Hālau Maluhia—the KS property located at Palemanō Point, Ke’ei, Kona Hema—including, but not limited to, activities such as swimming in or playing by the ocean. I understand that The Trustees of the Estate of Bernice Pauahi Bishop (“KS”) give no assurance that the property is without risks, and do not assume responsibility for injury to any person or property, no matter who or what causes the injury.

In exchange for me and/or the child being able to visit and take part in activities at or nearby Hālau Maluhia, for and on behalf of myself and/or the child, I release and discharge the Released Parties listed below from all claims and demands for injury, loss or damage, arising out of, or in connection with, my and/or the child’s visit to and/or use of Hālau Maluhia and the surrounding areas of Hālau Maluhia at any time from the date(s) of 13th April, 20⁰⁸ to 18th April, 20⁰⁸, even if the injury, loss or damage was caused by such person(s) or others. The persons I am releasing include KS and their respective trustees, officers, directors, employees, agents, and representatives (collectively, the Released Parties).

The visit to Hālau Maluhia and/or some or all of the activities at or nearby Hālau Maluhia that I and/or the child may participate in may be covered by the Hawai’i Recreational Statute (HRS Chapter 520) and, if so, this waiver will apply only to the extent it may provide broader protections and a broader release to the Released Parties.

I also agree that I assume full responsibility for any injury or damage to myself, the child or other persons or property that I or the child may cause.
