Applicants must be citizens or permanent residents of the United States. Applicants must submit a complete Dean's Scholarship Application by the application deadline: February 2, 2012.

We encourage students to apply as early as possible. The Dean's Scholarship fund is limited and scholarships are granted on a first-come, first-served basis. Awards are made until funds are depleted, and funds may be depleted before the application deadline. We cannot guarantee that all applicants who apply before the deadline will receive scholarship assistance.

How to apply for a Dean's Scholarship

To be considered for a Dean's Scholarship applicants must have a complete 2012 Program Application on file.

A complete Dean's Scholarship application consists of the following:

- Dean's Scholarship Application form
- A complete copy of your parents' or guardians' most recent IRS tax return
(Include a copy of each parent's tax return if filed separately)
- Copies of the most recent W-2 form(s)
