OSP Update

New F&A Agreement Effective 6/22/11

The approved F&A rates for Research are as follows:

7/1/10 - 6/30/13 62%
 7/1/13 - 6/30/15 62.5%

The Other Sponsored Accounting rate (23%) and the Off Campus rate (26%) have been approved through 6/30/15 and have not changed.

The approved Fringe Benefit rates are as follows:

• 7/1/11 – 6/30/12 32% Full Time Employees

8% Part Time Employees

• 7/1/12 – until amended 32.4% Full Time Employees

8.5% Part Time Employees

Additionally, there is a **New Equipment Threshold:**

Effective July 1, 2011 the equipment threshold has increased from \$3,000 to \$5,000. Any nonexpendable, tangible personal property having a useful life of one year or more and a unit acquisition cost of \$5,000 or more is considered equipment.

Transition to New Equipment Threshold:

Sub code 4070 must be used when purchasing "equipment" items **budgeted** under the prior threshold of \$3,000 for all active awards prior to July 1, 2011 and proposals submitted to OSP for approval prior to June 29, 2011.

Reminder - Compliance with NIH Application Format and Content Instructions NOT-OD-11-080

NIH has issued an notice to remind investigators and institutions that the NIH has the authority to withdraw an application from review and funding considerations for egregious cases in which the Appendix or certain sections of the applications are used to circumvent page limits or include inappropriate material in the application. National Science Foundation's Merit Review 2010

NSB and NSF Seek Feedback on Proposed Revisions to the Merit Review Criteria

The National Science Board has completed the survey on the NSF's Merit Review and has analyzed the various and substantive inputs from a wide variety of stakeholder groups. The NSB Task Force proposed to maintain the two criteria (Intellectual Merit and Boarder Impacts) but revised the text to clarify the intent of the criteria and how they are to be used during the review process. "Check NSF upcoming Proposal deadlines well in advance" "End of DoD Restriction on F&A Costs Recovery"

Department of Defense eliminates limitation on Facilities & Administrative Costs Recovery

DoD has issued a memo stating that the new appropriations <u>do not contain the limit on F&A recovery for basic research.</u>

Obligations that remain subject to the prior year restrictions are:

- those entered into using FY 2008 funds after November 14, 2007 for Basic Research, and
- those that use FY 2009 and 2010 appropriations for Basic Research

What this means:

- If you have continuing awards that are using prior year basic research funds, those funds continue to be subject to the limitation on indirect cost reimbursement.
- If you receive continuation funding on a continuing award, post award will set those funds in a separate account since the new funds (from Continuing Appropriations Act of 2011) will not be subject to the limitation on indirect cost reimbursement.

Anyone submitting an application, proposal or report to the NIH must include the Pub Med Central (PMC) reference number (PMCID) when citing applicable papers that they author, co-author, or those that arise from their NIH-funded research.

Process for Updating Status of Pending Proposals in Coeus

- 1. Monthly, the status of older *Pending* proposals will be automatically updated to *Not-funded* status:
 - On the first of each month, an automated process will run to change the status of any "Pending" Proposal that has NOT been funded after 2 years from submission date to the status of "Not-Funded".
- 2. Departments will receive a monthly report of proposals that have had a status update during the specified month:

A report will be distributed to Department Managers each month that will show a list of proposals that shifted from "Pending" status to another status, i.e "Not-Funded", "Funded/Awarded", etc, during the specified month.

3. A new Proposal Status designation will be available to assign to proposals:


Should a department want to include proposals with a that have been set to a status of "Not-Funded"in a pending report from Coeus, a new status can be assigned - "Pending 2+ Years". Contact Shelly Hull at Shelly Hull@brown.edu to shift the status of a proposal from "Not-funded" to "Pending 2+ Years".

COEUS TIPS OF THE MONTH

PDFs and Rotated View

There is an instance where when you:

- Print an attachment through Coeus Narrative Section the letters are fine
- But when you print though Action → Grants.gov, you see this:



This happens because the attached document may be a scanned letter and/or the attachments may have been combined in Adobe Professional.

To avoid this problem:

• Use the "print to Adobe PDF" option for any scanned letters prior to combining or attaching the files

Also, use the "print to Adobe PDF" option for large PDF files or files that are created in Adobe Professional or other programs.

eRA Commons User Names and Degree Information in Coeus

When submitting proposals to NIH, please make sure that:

- The eRA Commons User Name in Coeus is the same as the PI's User Name in Commons.
- The Degree Information in Coeus is the same as the Pl's Degree Information in Commons.

If the PI eRA Commons Name or Degree Information needs to be updated in Coeus, contact Coeus Help@brown.edu

PI Institute Affiliation in eRA Commons

The PI has to be affiliated with Brown University in eRA Commons. If the PI is not yet affiliated in the Commons system with Brown, contact Shelly Hull at Shelly Hull@Brown.edu

OSP Training Content on MyCourses

OSP is now using MyCourses to store class content for all the training classes. MyCourses is Brown's course management system where we have uploaded presentations, exercises, resources, etc. for each training class.

- **Evaluation** online version of the evaluation that can be submitted from My courses.

Note - you will be contacted by the instructor before the class to print out the documents needed for the class.
